7. He shall be the chief custodian of all the financial matters and maintaining books of the accounts prepare the budget for the ensuring year and to observe not to deviate the budget in total he has to assist and implement the directions of the secretary from time to time.
- f.) Under the guidance & advice of Trustees he/she shall be authorized to Appoint, Dismiss, reinstate any of the employees, and can appoint temporary Substitute Staff and fix their remuneration. He/she shall grant leave of absence, and Generally ensure smooth function of the trust.
  - g.) He/she shall generally be in charge of the office and the custodian of all Documents, bank passbooks, cheque books, security documents and Oversee the day-to-day expenses of the trust.
  - h.) To open accounts with any bank, operate such accounts and it give Instructions to the banks and to provide for the opening and operation of Such Accounts by Founder and President.
  - i.) To accept any donations, contributions, grant or subscriptions in cash or in kind from any person, body of persons or trust.
  - j.) To borrow or rise or secure payment of money and also lend money either with or without security at the discretion of the trustees.
  - k.) To charge, convert or sell any of the trust's property, investment or assists including immovable property.
  - l.) To accept from Government, Non Government, Local Bodies, Societies' and to Borrow loan from Banks (Nationalized/Co-operative), individuals Grants, Donations, and Borrow Loans, subscription or any property movable or immovable for furtherance of the objectives of the Trust.

#### 6. Number of TRUST Members:-

The number of the trust minimum two and maximum ten including managing trustee and Trustees of the TRUST. The trustee shall not except for the purposes of filling any vacancy, act so long as the number is below the said minimum.

#### 7. Appointment of the TRUST Members:-

The Life time Trustee shall be at liberty to appoint additional trustees within the Number mentioned above for such period or on such terms as to retirement and re-Appointment as the trustees for the time being consider proper.

The Managing Trustee shall appointed a nominative or permanent trustees of the TRUST. The trustees named above shall be the first trustees of this trust and they shall be trustees for their respective lifetime. The managing trustee shall be made alteration or Amendment of the TRUST deed.

The managing trustee dies, retires, become unfit or incapable of acting a member the Life time trustee, if surviving at that time, or otherwise the continuing or Surviving trustee or trustees shall be competent to appoint a trustee in place of the Trustee so dying, retiring or becoming unfit or incapable either for life or otherwise.

**10. Bank Accounts:-**





**14. AMENDMENT: -**
