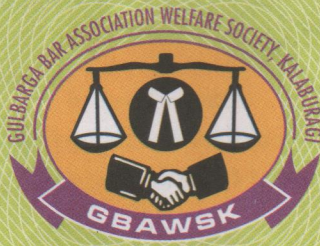

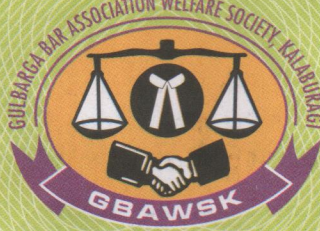

1. The area of the operation of the Trust is the entire country of India.
2. AIMS & OBJECTIVES OF THE TRUST SHALL BE :-
 - a. To build and maintain Temples, Ashram, Dharamshala, Community Center, Mangal Karyalaya for performance of Marriages and other ceremonies for use in social functions.
 - b. To acquire land, construct temples, educational institutions install idol of God for to the devotees, and other followers.
 - c. To conduct religious and social services activities and any other community services.
 - d. To open and run the charitable institutions in the name of the Trust.
 - e. To open and run the orphan schools.
 - f. To promote and establish charitable Institutions and uphold their maintains.

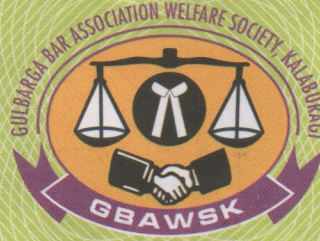


- g. Up bringing poor children providing employment to handicapped young & old persons, development of weaker sections.
- h. To start, run manage community halls, Hostels, w/w Hostel residential Institutions. Boarding houses, orphanages and destitute homes and homes for the aged for the benefit of the poor and Others Communities, and all valmurable sections of the society.
- i. To relief starts, run & maintain health fitness centers like Gym, yoga meditation centers and also Homeopathy, Ayurveda and Allopathic Naturopathy centers Nursing Institutions, and Para-Medical.
- j. To establish Educational Institutions like Nurseries, Baby-sitting schools, middle schools, High school, Colleges, degree college & other educational institutions etc.,
- k. To establish libraries, reading rooms and to provide books newspapers and periodicals.
- l. To establish technical, Medical, commercial industrial agricultural, professional, vocational and training schools, & Centers.
- m. To promote the well being of poor people, blind people, the backward and other neglected community from all caste, creed, sect, colone or religion.
- n. To provide free camps and medical check-up for the poor people in rural areas.
- o. To develop health and kind attitude towards the mental development, physical and moral upliftment of the students and all those connected with the institution so as to make them good citizens for the welfare of the suffering humanity.
- p. To provide educational and technical requirements, employment, improving the talents of children, women and weaker sections.

- u. To give scholarships, medals, awards, prizes, books etc to the students of all castes.
- v. To encourage children in extra activities like, sports, singing, dancing etc.,
- w. To open veterinary schools, and veterinary Hospitals in rural areas for awareness and treatment of animals.
- x. To establish protection centers for domestic animals like cows, cattle etc at rural areas.
- y. To build mangal Karyalaya for performance of marriages and other ceremonies for use in social functions.

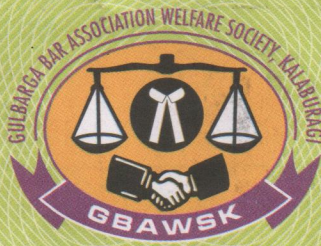

- z. Any other objectives may be thought as may be decided upon by board of Trustees from time to time, according to the general need of the community from time to time.
- aa. In general to all other things, acts or deeds as may be directly or indirectly conductive or incidental to the attaining of the objects of the Trust or any of them.

3. **BOARD OF TRUSTEES :**

The founder trustee shall be the permanent trustee for whole life. The remaining shall be co-opted and or nominated. The founder trustee may co-opt or nominate from well wishes and like-minded people and they shall be given membership as the Trustees. Who will be taking part in the development and enlightening function of the Trust. The quorum of the Board of Trustees shall be all or two third of the total trustees. The board of Trustees shall meet at least twice in a year. Fifteen days notice of the meeting shall be given to the Trustees either by way of U.C.P or in any other way as decided by the Trustees. In case there is no quorum at the time fixed for the meeting, the meeting shall stand adjourned by half an hour and the trustee present for at the adjourned meeting shall form the quorum, the postponed meeting is entitled to transactions business without waiting for the quorum.

6. **TRUSTEES AND OFFICE BEARERS :**

- a. There shall be 03 Trustees including the Author on the board of Trustees, whose name and offices are mentioned above.
- b. The board of Trustees shall have a president, and such other office bearers as may be created by the board of Trustees from time to time for such period as deemed necessary.
- c. The above mentioned office bearers are eligible for recombination or co-options.

7. **POWERS OF BOARD OF TRUSTEES**

- a. The Board of Trustees shall have the following and other powers in accordance with the provisions of the Indian trust act 1982, and also subject to the provisions of the Income Tax Act 1962.
- b. To acquire moveable and immovable properties for the Trustees accept gift grant exchange lease hire other wise.
- c. Invest trust money in the construction of building for the income or causes or the trust.
- d. To invest trust money shall have or mortgage lease out going on license all or any of the properties of the trust at such consideration and the terms as deemed fit and permitted by law applicable thereon.
- e. To cancel recall or vary any transaction from time to time.



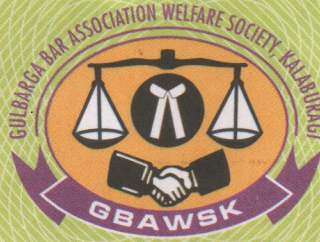

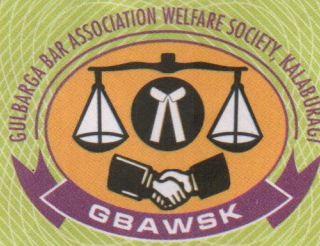
- f. To engage any person or persons or such other shall found necessary upon such remuneration which may be deem fit and to take disciplinary action against the employees of the Trust for terminating their services.
- g. To get open account in any Banks and the same shall be carried out by the Signature of author of the Trust and hereinafter called as **President**.
- h. To borrow or otherwise raise any only from Banks financial institutions, or other Govt. agencies and or organizations as it deem fit and to do all the acts necessary therein and sanction reasonable amount towards honorarium to the trustees who render service to the cause of trust.
- i. To frame regulations and by-laws and rules for proper administration of the trust in conformity with the above aims and objectives of the trust and to do all other acts deeds, matters and things which are necessary for carrying out of the aims and object of the trust.
- j. The board of trustees are to manage and control the affairs and properties of the trust and to regulate the same and may delegate any one or the more of powers described above to one or more of the trustees as deemed fit and required therein from time to time.
- k. The board of trustees may invite any others to participate in the meeting and activities but they will not exercise any powers of voting.

8. POWER AND DUTIES OF OFFICE BEARERS :

- 1) **The PRESIDENT :** The president shall have general control over all the affairs of the trust and institutions under its control and also the has control over the employees of the office.
- 2) He will preside over the Trust matters in general.
- 3) To conduct emergency meetings as and when required from time to time.
- 4) The president will have to preside over all the meeting of board of trusts to be held from time to time.
- 5) To look after all the matters of the Trust, represent the trust, in all the Government offices, Civil courts, criminal courts, Appellate courts appellate authorities, private institutions etc.
- 6) To defend all cases filed against the trust, or to file cases on behalf of the trust in the interest of trust.
- 7) To receive donations or any amount in cash, cheque, draft and by means of any movable and immovable property etc., for the trust, to give donations on behalf of the trust. And do all necessary and lawful acts in this behalf.

9. SECRETARY : He shall have the following duties :-

- To maintain all records of the trust, to manage office and staff, to prepare agenda for trust meeting, to keep up records of the accounts and other transactions of the trust.
- He shall be the custodian of all the correspondence and records of the trust and carry out other responsibilities on entrusted to him from time to time by the board of Trustees.
- To preside over the meeting of the trust in the absence of the president of the trust.
- To manage all the affairs of the trust in all aspects.
- To manage and run the day to day business of several institutions of the trust.
- He shall be authorized to look after all the assets of the trust.

10. SECRETARY

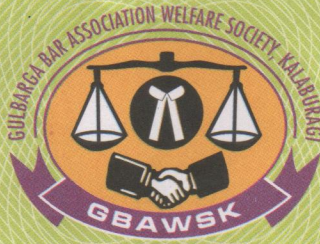
- He shall keep all the records up to date pertaining to the money transaction and assist the secretary or any trustee in all matters assigned to them.
- He shall have the accounts of the Trust audited by a chartered accountant as decided and approved by the board of Trustees.

11. CESSATION OF TRUSTEE SHIP

- By the death of Trustee.
- By resignation duly accepted by the Trustees.
- By any trustees becoming bankrupt, lunatic, or is convict and of any criminal offence invoking moral turpitude.
- By expulsion as per clause mentioned below.

12. EXPULSION :

- If any of the trustees including the author of the trust is found immoral or his conduct or out trust is found detrimental to the interest or reputation of the trust or if he be have in a manner prejudicially effecting the trust and its activities he shall be expelled from the trust and by passing a resolution by 2/3rd majority of trustees present at a meeting of the board of trustees. However the Act of such expulsion he may be given and served a show cause notice in writing mentioning the proposed grounds of expulsion and shall also be given an opportunity of being heard by board of trustees at a reasonable time fixed thereon.
- Cession of trusteeship for any reason shall not entitle and trustee of any person for the refund of any money paid by him or return of any donations or gifts, etc., made to the trust.

1. **MEETING OF THE BOARD OF TRUSTEE :**

- The Board of Trustee shall meet at least twice in a year or as often as possible to transact the business of the Trust at the office of trust or at any suitable place as the president determined from time to time.
- The 2/3 of the Trustees may in writing send to the secretary to convene a special meeting of the board of Trustees referring the matter to be discussed and that there upon the Secretary shall call a meeting by giving a week time to the Trustees.
- The President in the matter of urgency can have the power to get pass a resolution through circular and later the same be rectified by the board of Trustees in its next meeting.

13. **AMENDMENT TO THE BOARD OF TRUST:**

The board of Trustees by its resolution attended in person by two third majority of the total members of the Trust shall have the power to change, amend, modify or alter add in the deed of trust, its terms and clauses for smooth running of a Trust in accordance with law from time to time, but such changes or alternations and amendments shall not alter in any way the nature and character of the trust.

AMENDMENT-CLAUSE : No amendments to the Trust Deed/ Memorandum of association and rules and regulations shall be made which may prove to be repugnant to the provisions of Sec. 2(1) 11, 12A, 12AA, 13 and 80G of the I.T Acts 1961 amended from time to time. And FCRA 35AC/ 1/2 Further no amendment shall be carried out without the prior approval of the commissioner of income tax, Karnataka, Bangalore.

14. **ACCOUNTS :-**

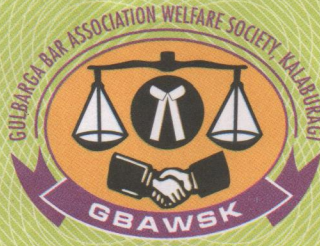
All moneys received on account of funds of the Trust and it's properties shall as soon as possible be deposited in the Bank Account of the Trust. The Bank Account shall be opened in the name of the Trust Namely "**SRI. DR. A.P.J. ABDUL KALAM FOUNDATION TRUST**" At: **Dotihal Tq: Kustagi Dist: Koppal,** With any scheduled Bank / Co-operative Bank/ or any Bank licensed by Reserve Bank of India in and outside also and shall be operated upon the Managing Trustee open for the President.
