**14 VACANCIES:**

In case of any vacancies in the board of trustees, the remaining trustees are empowered to appoint any person as a trustee.

**15 QUORUM:**

- The quorum for the meeting of the board of trustees is with the presence of three trustees.
- The adjourned meeting does not require quorum and only the agent of the adjourned meeting must be considered.
- The Funds of the trust cannot be used/ utilized for any other purpose which is prohibited by law of the state/ nation.
- The extra funds of the trust be invested only in accordance with section 11(5) and 13(1)(A) of the income tax Act 1961.
- If for any reason the trust is unable to work in accordance with the object enumerated above the trust shall transfer or merge. To transfer the entire assets and liabilities with any other trust having similar or same object. At any cost the trustees shall not receive any of assets of the trust at the time of dissolution of trust.
- The authors of the trust are trustees for their lifetime. The term of the other trustees is hereby fixed at 2(two) years from the appointed date. The trustee's retiring is eligible to be re-appointed as trustees.
- Persons of unsound mind, punished by court of law, insane persons are not eligible to be trustees. In case any of the trustees were to become insane, punished by court of law, they cease to be trustees forthwith.

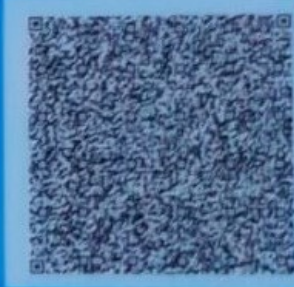

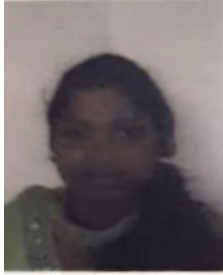

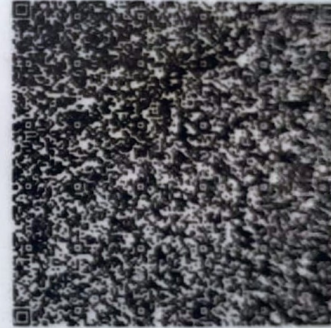
