

Aims and Objects of the Trust :


- 1) Formulate programmes to formers and others about rain harvesting and water management.






32) To Alienate by way of sale, Mortgage, Lease, release, loan, charges, hypothecation, pledge, exchange, hiring out, gift or otherwise or without security of properties of funds of the trust or any portion or portions thereof including the making or giving of subscriptions, contribution, assistance, pecuniary or otherwise to such institutions bodies or persons as from time to time deemed necessary expedient.

33) Invest, lay aside, Deposit in Bank or otherwise deal with monies or funds of the trust. No immediately required for the objects of the trust and to subscribe or purchase, acquire, hold, sell endorse and negotiate in Debenture, stock and securities of every description in money, market in conformity with the Provision contained in Sec. 20 of the Indian Trust act.

34) Borrow or raise funds with or without Security in any manner the trust may think and repay the same.

35) Negotiate with and enter into agreements with any government Authority, Corporation, Board, University or other Public or Private bodies as may seem conducive to the promotion or accomplishment of the objects of the trust or any of them and to apply for obtain, collect receive, such grants, loans allowances, rights concessions and privileges as may deem to comply with the objects and utilizes the same.

36) In general to do or cause to be done a part from all the acts stated above all such of the acts or things as shall be conducive to the interest of the objects of the trust, Provided such things or acts be not contrary to nor inconsistent with the Spirit and Principals of laws under which the trust has been established.

37) To undertake any carryout any other necessary steps to Promote the above objects.

38) To create, manage and establish funds for education, welfare cultural and economic objects/purposes for individual, Groups and organizations in India.

39) To establish the Go shala in rural areas and urban area.

Now this Deed witnesseth as under :

That, in pursuance of the above, we the above the executants do hereby declare that out of our own earned & saved money of Rs. 1,000-00 (Rs. One thousand only) to be the Trust money and dedicate the same hereunder unto the beneficiaries forever and further hereunder appointing our selves as the President and the Secretary.

The followings are the terms and conditions of the Trust :



2) That the Trust created is for Perpetuity and is not revocable.





- 4) The Primary concern and Prima objects of the Trust is being, Imparting, Primary and higher education covering that fields set out in the objective and Providing Vocational training to the pupils of all Sections of the Community, the trustees shall strive to achieve the objective of trust and its creation.
- 5) The Trustees shall be entitled and empowered to formulate schemes & Policies for the general welfare of the children and adults including those Physically handicapped Particularly girl Students, and to Start and establish necessary institution for that purpose and also to provide for Boarding, Lodging, Clothing Medical care etc. for the benefits of such orphans. Old age persons, weak and helpless persons,. The Trust may also to start or take over the Hospitals and educational institutions and their managements and administer them to achieve the objects of the trust.
- 6) The Trustees shall be vested with full and final authority to deal with the teaching & Non teaching staff working at various institution run and managed by the trust and shall be the disciplinary authority for the staff members of all classes, categories including the heads of the institutions, by whatever name or designation they are working.
- 7) The Trustees shall be empowered to appoint a committee or sub Committee for any Specific purposes and may also constitute a committee consisting of not more than 05 persons to advise or to manage and administer the institutions of the trust, and the trustees are also empowered to remove, Replace, Reshuffle, reduce, enlarge reconstitute or dissolve such committees if necessary in the interest of the Trust.
- 8) The Trustees shall not be entitled to any remuneration for their and her services as trustees, But however they / she shall be entitled for traveling expenses and other incidental charges.
- 9) The trustees and their successors shall be for life time unless they retire / Step down on their own and the trustees of that time shall be entitled and empowered to appoint a sole trustees in their place or at their discretion nominate and appoint other trustee whenever found necessary or appropriate.
- 10) In the Event of any institution or any Society or other Agency being amalgamated, liquidated or dissolved the trustees shall have power to take over, received or adopt such institution, Society to the folds of the trust thereafter manage and administer such society or Institutions either as separate Branch or as a part of the trust activities to achieve the objects enumerated supra. The trustees shall have absolute Power to deal with concerned authorities to complete the formalities in this behalf.

II Retirement from trusteeship ;


- 1) Any trustee who becomes Bankrupt, Lunatic, Convicted of a criminal Offence involving moral turpitude or Neglect to take interest continuously for a period of more then Six months or is Physically incapacitated or remains outside India continuously for more then 12 calendar months shall cease to be a Trustee.

2) Any Trustee may retire on giving notice of one calendar month in writing of his intention to do so.

III VACANCY ;

Vacancy caused due to any reason can be filled by the Opinion Majority of the trustee.

IV MEETINGS ;

The Board of Trustees shall meet at least once in a months to transact and review the activities of the trust five days Notice shall be given for such meeting The quorum of the meeting shall be thee. I case there is no quorum at the time of fix the meeting. The meeting shall stand adjourned Meeting shall form the quorum. The Postponed meeting is entitled to transact may give written requisition t the Chief Trustee to convene a meeting on the board of trustee, clearly indicating the Subject matter to be discussed on receipt of such a requisition the Chief trustee shall call for a meeting within 10 days after giving three days clear Notice.

Any decision will be passed with the majority of trustees, present during the meeting.

V POWER AND FUNCTIONS OF THE BOARD OF TRUSTEES ;

The board of trustees shall have the full power and authority to administrate the trustee property, the investment and ;

- 1) To receive, collect and enforce recovery of all monies. dues payable to the trust and grant necessary receipts and discharge thereof.
- 2) To appoint, terminate, suspend and otherwise deal with the employees.
- 3) To appeal and act before court, tribunals, public office etc.,
- 4) To institute, prosecute and defend all suits and other legal proceedings.
- 5) To incur all necessary expenses from the corpus or income of the trust in connection with the trust and its management and for its institution.
- 6) To apply properties and funds of the trust for the object of the trust.
- 7) Generally to do all such acts, deeds ad funds as may be required to fulfill the purposes of the trust.

VI MANAGEMENT ;


The management and control of the properties and affairs of the trust shall be vested in the board of trustees, the trustees by themselves or though their agents or agent employed by them manage and deal with the trust property in such manner and may be most beneficial to the interest of the trust.

VII POWER OF THE OFFICE BEARERS ;

a) The Chief trustee (The President)


The Chief Trustee shall be in charge of and of and responsible for the safe custody of all records relating to the administration of trust and its properties shall commence the meetings of the trust, as per agenda and maintain regular record if all the proceedings of such meetings. All correspondence and all financial statements and returns required in carried and prepared by chief trustee. The chief trustee shall be the chief executive officer of the trust.

The Chief Trustee shall receive and disburse all the monies of the trust and maintain or caused to maintained proper accounts of the same. All ligancies, donations, and subscriptions

shall be paid to the Chief Trustee, whose receipts will be valid and binding on the trust. The Chief Trustee has got full power in legal matter and other matter on behalf of the trust.

b) **Secretary :**

The Secretary shall be in charge and responsible for the safe custody of the records of all proceedings of such meetings, all correspondence, records required in connection with the management of the trust shall be maintained and prepared by the secretary.

i) The **Treasurer** shall have the authority to operate the Trust accounts with his Own Signature at any Nationalized Banks etc., **Treasurer** shall maintain all the accounts of the Trust up to date.

VIII Reimbursement of expenses :

The trustees may reimburse themselves or pay and discharge out of the said trust properties all expenses, incurred in or for the execution of the objects of the trust and exercise of the power vested in them.

IX FUNDS OF THE TRUST;

The trust fund shall not be applied for any purpose other than those specified and also the trust funds shall be invested in the modes specified under the provisions of Sec. 13(1) (d) read with Sec. 11(5) of the I.T. Act 1961, and All Acts Govt. of India, as amended from time to time.

X ACCOUNTS OF TRUST ;

The Trust shall keep or cause to keep proper books of accounts of the trust and the trust properties. The account shall be audited duly by chartered accountant every year, the account every year, the accounts shall be closed by 31st March. The accounts shall be kept in the Office of the trust.

XI AMENDMENTS ;

No amendments to trust deed, rules, regulations shall be made which may prove to be repugnant to provisions of Sec. 2(15) 11, 12, and 13, and 80G of the I.T. Act 1961 and All Acts Govt. of India, as amended from time to time. Further no amendments shall be carried out without the prior approval of the commissioner of Income Tax.

XII TRUST REVOCABLE ;

The trust formed shall be irrevocable.

XIII BENEFICIARIES ;


The benefits of the trust shall be open to all mankind irrespective of caste, creed and religion.






