3. AIMS AND OBJECTIVES:

1. To Provide and maintain Educational Institutions like Nursery School, Primary/Upper Primary School, Day Care Center., Residential Schools, Colleges, Secondary Schools, Oriented Schools, Vocational Junior Colleges, Junior Colleges, Degree Colleges in rural and urban area.
2. To cater to the need of poor, suffering, widows, orphans and street children. Arranging free help to the people from voluntary organization and Government to improve the quality of living of the people
3. To establish drinking water supply to the needy people through chalivendras or Purified water to the rural village people in summer season only
4. Help to the Handicapped persons, Disabled persons and Mental Retardation persons
5. **RULES AND REGULATIONS OF
COMMUNITY RURAL AND URBAN DEVELOPMENT SOCIETY

1. Name of the Society: COMMUNITY RURAL AND URBAN DEVELOPMENT SOCIETY

**2. Location of the Society Office Address: H.NO.1-53A, BOLLAVARAM (V),
KALLUR (M), KURNOOL DIST**

Area of Operation : ENTIRE ANDHRA PRADESH

3. INTERPRETATION:

1. Society means: "**COMMUNITY RURAL AND URBAN DEVELOPMENT SOCIETY**"
2. Council means the Governing Council of the Society
3. General body means the General body of members of the Society

MEMBERSHIP QUALITIES

- All Rural and Urban area people and youths, the age of 18 years and sound mind are eligible to be a member of the Society (or) membership shall be approved by the Governing body. On approval an amount of Rs.150/- (Rupees One hundred and fifty only) shall be collected from the members as the initial membership fee.
- Membership fee shall be payable in advance at the beginning of every financial year and shall be payable within one month from the date of its falling due. Any member who fails to pay his subscription within 3 months from the due date will automatically cease to be a member will lose his right to vote.
- The General body shall be competent to revise the rates of membership as deemed fit.
- The membership of the Society shall be limited to 7 persons only whose names are mentioned in the Memorandum of Association, which shall be general body of the Society.
- The Society shall maintain a roll of the members along with the name, address and signature of the respective members.
- The members shall inform the Secretary any change in their address, occupation or otherwise for the information of the membership roll.
- If member resigns for membership in the Society it is to be approved by the Governing body. If for any reason the Governing body does not accept the resignation of a member that particular member is deemed to be a member until the Governing body as per the rules accepts it. The Governing body reserves the right of termination of any member if not it feels that the existence of such member in the roll of the Society is determined to the interest of the Society.

ADMISSION FEE AND SUBSCRIPTION: A membership fee of Rs.150/- for admission and a annual subscription of Rs.150/- shall be final for member should be paid as the amount.

CESSATION OF MEMBERS: Members shall be deemed to have up-so faction ceased if the members Remove his residence from the area of operation of this Association. Is in default of payment of his/her subscription for a period of over two years continuously. Becomes insolvent.. Is expelled under rule No.4 of the Rules and regulations of this Association. Becomes unsound mind or when he is suffering from any contagious diseases

4. GOVERNING BODY: The Management of the Society will be entrusted to the committee consists of President, Vice President, General Secretary, Joint Secretary Treasurer, and 2 E.C. Members – Total 7 members. Elected by the Governing body.

5. GOVERNING COUNCIL: There will be a governing council composed of the office bearers of the Society, namely the President, Vice President, General Secretary, Joint Secretary, Treasurer, and 2 E.C. Members – Total 7 members. Elected by the Governing Council.

6. RIGHTS, POWERS AND DUTIES OF THE GOVERNING COUNCIL:

- a) The council shall have all such powers and shall perform all such functions as are necessary or proper for the achievement or the furtherance of the objection of the Society.
- b) Without prejudice to the generally of the foregoing provisions the council shall have the following rights and powers.

- To raise funds of the Society by gift, donations, or otherwise - To sue and be sued on behalf of the Society - To perform all such acts and do all such things as may be necessary for the proper management of the properties, and the affairs of the Society - To appoint from time to time such and so many employees on such terms and conditions as may deem fit for carrying on the management and affairs of the Society and employees to work in the institutions of the Society - To appoint an Auditor or Auditors for auditing the accounts of the Society - To exercise control over employees of the Society including the power of dismissal - To appoint, from time to time, sub-committee, including needy persons other than members of the governing council and to assign and or delegate thereunto, such powers, duties and functions, as it may deem fit.

7. DUTIES OF THE OFFICE BEARERS:

PRESIDENT: The President as the Chief Executive authority of the Society. He shall preside over all meetings of the governing body and general body. The President shall be in charge of all the movable and immovable properties of the Society and all title deeds and other documents and records of the Society. The President shall have the power to act on behalf of and represent the Society in all its transactions and to accept or execute on its behalf of all conveyances, mortgages, leases or and all other deeds and documents that are required to be the executed by and on behalf of the Society and the same shall be effected and binding on the Society as if executed by the Society itself.

VICE PRESIDENT: In the absence of the President, the Vice President shall act as a President

GENERAL SECRETARY: She shall conduct all correspondent on behalf of the Society. She shall maintain the records and registers of the office. She shall be in supervision and maintenance of the properties of the Society. She shall convene meetings of the Society as directed by the President and maintain minutes of the proceedings. She shall appoint to run the affairs of the Society and its institutions as and when required and shall take any actions against the staff including disciplinary action proper working of the institutions..

JOINT SECRETARY: in the absence of the General secretary, the Joint Secretary shall act as a General secretary

TREASURER : The Treasurer shall collect the subscriptions from the members of the association, and issue the receipts, for the amounts received, signed by the President, General Secretary and Treasurer. (if any two persons) The Treasurer will be responsible for the Finance of the Society and shall maintain vouchers for credits and debits. The Bank account shall be opened for the Society in the name of the President , General Secretary and Treasurer (if any two persons – Joint Account passed by the resolution) and they will have power to operate on this account.

E.C. MEMBERS: All the office bearers and E.C.members of Governing Body shall hold the office. The members shall assist the President, Vice President, General Secretary and Treasurer, for smooth running of the Society activities.

8. TERMS OF OFFICE: Term of office of the Governing council shall be THREE years. They are eligible for re-election. A casual vacancy in the office of any of the office bearers of the Society may be filled up for the residue of the terms. Any member of the governing council. Any member of the Governing council may at any time resign from his/her office by sending the letter of resignation to the President of the Society, but such resignation shall take effect only from the date on which it is accepted by the Governing council.

9. GENERAL BODY MEETINGS: All meetings of the General Body shall be held at Society premises at the above area once in every year in the month of **APRIL**. Ten clear days notice shall be given in case of all General body meetings.

10.BUDGET: The Secretary/Correspondent shall present the Governing council with a budget of the income and expenditure of the Society once every year, and get it approved and adopted.

11.QUORUM: The quorum for the entire general body meeting shall be 3/5th of the members on the rolls. The quorum for the executive Society shall be 3/5th of the members.

- 12. VOTING BY PROXY:** There shall be no voting any proxy.
- 13. SUITS:** The Society may sue or to be sued in the name of the PRESIDENT
- 14. FUNDS:** The funds for the implementations of the aims and objectives of the Society shall be collected from patrons, donors, development funding agencies and well wishers both in India and abroad. The funds of the Society shall be spent only for the purpose of attaining the object of the Society and no portion there of shall be spent, paid or transferred directly or indirectly to any member though any means. The funds granted for special purpose or to carryout agreed development measures and projects are not the property of the Society and the Society is only an instrument to carryout these measures or projects. Other resources raised by the Society through its own activities will be the direct property of the Society and can be used according to the decisions of the governing body. The bankers of the Society shall be approved by the Governing body. All funds shall be deposited, in the same approved bank account and all withdraws shall be made through cheques duly signed by the following two persons ie., President, General Secretary and Treasurer
- 15. AMENDMENTS:** The Society as a body shall not take part in POLITICS, neither profit motive nor commercial activity is involved information of the Society. No amendment or alteration shall be made in the purpose of the Society unless it is voted by 3/5th of members present at a general body meeting convened for the purpose and confirmed by 3/5th of the members present at a second special meeting at the interval of one month after the former meeting.
- 16. WINDING UP:** In case of the society has to be wound up the property and funds of the society that remain after discharge the liabilities, if any, shall be transferred or paid to some other institutions with similar aims and objects and which is registered under Section 12 A of Income Tax Act 1961.
- 17.** The accounts of the society shall be maintain or caused to be maintained by the Executive committee members of the society for recording all the in-flows and out-flows of the society. Annual accounts shall be drawing and got audited by a Chartered Accountant before presenting the same before the general body for their adoption or approval.
- 18.** None of the office bearers of the society shall be allowed to use the funds or the assets of the society or allowed to derive any benefit either directly or indirectly from the society as stipulated u/s 13 (1) (c) of I.t.Act.
- 19. DISSOLUTION/LIQUIDATION:** In case of the Society has to be wound up the property and funds of the Society that will remain after full satisfaction for the liabilities of the Society will be transferred or paid to some other institutions with similar and objectives 3/5th of majority to dissolve the Society
- 20. BANK ACCOUNT:** The Bank account of the organization should be operated by the Joint Account – President, General Secretary(if any two persons) (passed by the resolution) in any Banks, Nationalized Banks, Government sponsored banks, Commercial banks, Private Banks and Post offices etc.,
- 21. REGISTERS & RECORDS:** The following books and register shall be maintained.
a. Register of members b. Minutes books c. Cash book for each year separately - Correspondence file – Receipts books for all collections any other registers or records found necessary by the Executive Society .
- 22.SOURCE OF INCOME:** All the income of the Society shall be utilized only for promotion and upliftment of the Aims and objects of the Society . Sources of income of the Society are as under - a. Admission fee and subscription from the members of the Society . b. Donations and special contributions
- 23.LEGAL PROCEEDINGS:** Society may sue and to be sued in the name of PRESIDENT as per the provisions laid down under Sec.6 of the Societies Registration Act as applicable to the State of Andhra Pradesh.
- 24. INCOME TAX EXEMPTION ACT:**
a. To funds of the Institution would be invested as per section 11 (5) of the Income tax Act 1961.
b. Institution/Trust /Society is irrevocable

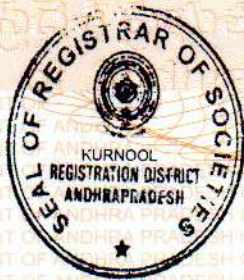
