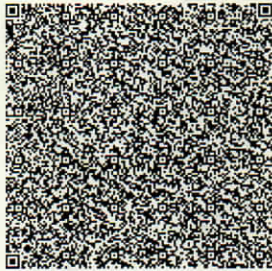

As such I am filing the proposed Byelaw of the Society with resolution copy of the general body meeting to grant the society registration.






2. The following were unanimously appointed to the first Board of Directors to whom by the rules the management of the society was to be unfrosted.






