GFATM is committed to finance activities that can accelerate the reduction in morbidity and mortality caused by HIV/AIDS, TB and Malaria throughout the world. The Global Fund website (<https://www.theglobalfund.org/en/>) provides details regarding the funding process and activities.

The India Country Coordinating Mechanism ("India-CCM") is established in recognition of the requirements and recommendations of the GFATM.
