



Above certificate is subject to fulfillment of the following terms and conditions by the Agency.

- The Agency will fulfill all the requirement as an NGO under societies Registration Act, 1860/Indian Public Trust Act (Whichever is applicable).
- It will have standard Children facilities in its home as prescribed in Jharkhand Juvenile Justice (Care and protection of Children) rules as amended time to time.
- It will have other child welfare activities suited to the need of non - adopted children such as older children/special need children.
- It will not place any child in adoption unless she /he is declared legally free for adoption by the competent authority nor it will match any Indian parent with the child for adoption until he/she is found suitable for adoption.
- It will have adequate no. of trained staff for looking after the children and their adoption.
- It will furnish the Report/Returns to the state Government as well as to CARA, SARA and child Welfare Committee as per the format and periodicity that may be prescribed from time to time.
- It will have proper counseling and follow-up system during both pre-adoption and post-adoption period.
- It will give access to the premises of its Homes/Adoption Centre GRAMIN SAMAJ KALYAN VIKASH MANCH, PALAMU, Address- Powerganj, Lohardaga-835302. For inspection by the authorized official of the State Government CARA , SARA, CWC Inspection Committee and other officials as mandated under law (Constituted under J.J. Rules.)
- The Certificate is non-transferable.
- It will abide by the Guidelines issued by the state Govt. Central Govt./CARA, SARA from time to time regard.
- The Certificate will be revoked the instance of the agency not fulfilling any of the mentioned conditions after an opportunity being given to it explaining its position.
- This certificate has approval of the competent authority.
