



Janani foundation is a non-profit and non-governmental social development organization registered under Andhra Pradesh Societies Registration Act, 2001 (No: 438 Of 2014) to work with poor and deprived communities and help them to enjoy all their basic needs such as safe shelter, nutritious food, clothing, quality education, health care, life skill development and all essential entitlements. It works on the issues of Homeless, Children with special needs (Deaf-mute), Women, Health, Environmental, Education and Workers in Unorganised sector.



Vision

Working towards creating a better and healthy society where every person enjoys their rights and live with dignity.

Objectives

- To address the issues of children with deaf-mute and provide shelter, counselling, speech therapy, and audiography test and required treatment.
- To provide psycho-social support and guidance to the homeless people
- To protect environment by sensitizing local communities about Save Water and Save Earth campaigning.
- To provide quality education to the needy children and empowering parents collectives.
- To help underprivileged communities in obtaining basic entitlements

Shelter Home Services

Janani foundation runs shelter homes for homeless people in collaboration with Greater Hyderabad Municipal Corporation (GHMC). These shelter homes are located in the reputed government hospitals intended to provide night-shelter along with basic needs to the patients and their attendants, who are from economically poor families come for the medical treatment from various remote places. The following shelter homes are being run in twin cities with the support of GHMC and individual donors.



Night Shelter for Needy

We have started a night-shelter in the premises of government E.N.T hospital at Koti with the intent of helping poor and needy attendants of the patients, who come from various districts to get the medical treatment for the issues of Ear, Nose and Throat. This shelter has been started in the year of 2019 with the occupancy of 100 beds to provide services such as shelter, counselling, food and other basic needs. Currently, daily 60 adults and 30 children receiving support from this night-shelter.



Shelter for Children with Special Needs (Deaf - Mute)

Janani foundation provides the support to the children with special needs and their parents till the entire therapy/treatment process is done successfully. As part of that, children with Deaf & Mute require special care and timely medical diagnosis followed by treatment within the age of 4 years to avoid future impediments. To provide support to the children, we have started this shelter of late in 2022 for special need children mainly children with deaf & mute to help them during the process of medical treatment. In the process, we provide accommodation, nutrition and counselling that play a vital role in sensitizing the parents/attendants and getting the treatment done within the timeline. Most of the parents, who come from various districts and other states, are poor and agriculture labourers. The parents are constantly provided support during the period to avoid delay in getting the surgery/treatment done in time. The treatment process takes nearly 7 years including 3 years for speech therapy.



Shelter for Cancer and Dailysis Patients

A shelter home for cancer and dialysis patients has been started in the year of 2022 at NIMS hospital, Panjagutta. This shelter is located near to NIMS hospital with the occupancy of 100 beds to provide accommodation to the needy cancer and dialysis patients.

Environmental


Janani foundation has been working in collaboration with Greater Hyderabad Municipal Corporation (GHMC) and Hyderabad Metropolitan Water Supply and Sewerage Board (HMWSSB) of Telangana and organizing various activities in the process of creating awareness to the communities about protection of environment by preserving natural resources which need to be protected. As part of that, it has taken up innovative campaigns that created a positive impact in the society and brought momentous changes in the process of working towards protection of environment. Here are the details of few significant activities initiated by Janani foundation in the best interest of the poor and deprived communities...

Save Water – Save Earth

Janani foundation has become an active member of this campaign and playing an important role in sensitizing the slum-dwellers about natural resources as part of 'Save Water – Save Earth' campaign since 2017. As part of the campaign that aimed to bring awareness about the protection of environment, we have organized several programmes in 30 identified ward locations in twin cities such as Schools, Colleges, Self-help groups, Youth groups, various associations and Government local bodies.

World Water Day

The day is celebrated on 22nd of March every year by Janani foundation to sensitize various community groups by marking the significance of the day. We identify the areas/ locations, where awareness is required and organize the programmes in Schools, Colleges and slums in collaboration with GHMC and other government departments such as Water works, Police, Health and local divisional officials. The main objective of the campaign is to sensitize the communities to set-up and construct rain water pits, preserving water and increasing the ground water level. The programmes carried out for 2 months before world water day and culmination programme is organised with all the groups involved during the campaign.



Food Campaign

We have started this campaign in the year of 2020 to provide food to the homeless needy after witnessing the severe food crunch during the lockdown period due to the pandemic. We have been distributing 500 food packets daily to the needy migrant and construction labourers residing on streets at main junctions such as Secuderabad and Nampally Railway Stations and Koti. This food campaign is being carried out with the support of individual donors, who have come forward to help needy in the society through our organization.



Health Camps

Janani foundation conducts health camps to sensitize the poor and deprived communities about health safety measures and provides well-timed medical assistance/treatment. We provide awareness, counselling, medicine and support in case of operations recommended by the doctors. So far, we have organized nearly 100 Eye camps in various slums in the twin cities of Hyderabad and Secunderabad. These camps have been organized in association with Sadhuram Eye Hospital, Domalguda run by Lions club. As part of that, an ophthalmologist along with an assistant conducted Eye check-ups and provided medicine to the needy. Those, who required cataract surgery, were referred to the hospitals for further treatment. Till date, we have provided medical help to 2000 community members with the support of individual donors.



Child Education

To reduce the child drop-out percentage and join them in to mainstream education, we have organized awareness programmes/meetings in 100 and above communities in Hyderabad district and sensitized the parents, school teachers and various stakeholders at community level with the support of concerned government departments and other organizations. During this campaigning period, 500 children were identified as drop-outs, counselled and joined them at various government schools as per the best interest of the children. The parents were too counselled on the importance of education and career development opportunities available.



Entitlements

We have been working in collaboration with Labour Department of Telangana since 2014 to sensitize the migrant and construction labourers and help them to obtain the basic entitlements from the government. Till date, around 20,000 labourers got benefitted with the facilitation done by Janani foundation and received the documents such as E-Shram card, Labour card and Insurance eligibility documents. Out of them, 18, 000 members received E-shram card and the rest 2000 members received labour card from the respective government departments. During the period of 2021 – 22, we have organized 40 awareness camps in identified locations, where high number of unorganised sector workers gather and get the daily wage works.



Saaf Hyderabad - Shandaar Hyderabad

Janani foundation has creatively initiated a campaign in the name of "Saaf Hyderabad – Shandaar Hyderabad" that aimed to reduce the waste garbage and make 'dust bin free city' by providing knowledge to the slum-dwellers on effective segregation of wet and dry waste garbage. This campaign was started in collaboration with Greater Hyderabad Municipal Corporation (GHMC) and 30 like-minded organizations. As the result, we have successfully achieved our goal by sensitizing a massive number of people nearly 1 crore population in various locations. The campaign carried out in 6 zones that consist of 30 circles, 150 divisions.

Honoured with Covid Warrior National Award

Mr. Rachakonda Mallesh, founder of Janani foundation has been awarded by Valluri Foundation for the untiring services of the organization during pandemic in fight against Covid-19. He was honoured with Covid Warrior Award and Certificate of appreciation in the month of July 2021 at Tyagaraya Gana Sabha, Chikkadpally. Janani foundation had played a commendable role during pandemic times in reaching needy people in the communities and on streets as well to help them by providing basic needs such as food, shelter and health care. Many people received timely support and appreciated the tireless efforts of the organization.
