The Trust can open Bank Account on the Trust name in any Nationalized banks jointly by its President, Secretary or Treasurer or Co-ordinator of the Project of the Trust and operated jointly by the President and the Secretary or the Co-ordinator.
- 10 The trustees may be chargeable only for such money or securities, as he/she shall actually received and shall be answerable and accountable for such receipts by himself/herself for his own acts and neglect or default and not for those of others, nor for any banker, broker, auctioneer with whom or into those hands the Trust money or Securities may dispatched or come up for insufficiency in the title or deficiency in value of any investment or for any other loss unless the same shall happen through his own willful act or default.

#### (V) THE TRUSTEES:

The Trustees of the Trust shall consist of:

- Those persons who signed the trust Deed of the Trust are Founder Trustees. The Founder Trustees are permanent Trustees. They are also subject to Termination if he/she works against the objectives of the Trust.
- ii) The heirs of the Founder Trustees after induction as the Trustees will act as Founder Trustees.
- iii) Members other than Founder Trustees who gets appointed on invitation of the Board of Trustees will be in the office for a period of 2 years only and the Trustees can reconsider another term.
