- e) To organize or work for any object of general good and welfare as determined by the PRIA
- f) To print, publish and exhibit films, cassettes, journals, periodicals, books, lectures and other reading and pictorial matters for the diffusion of useful knowledge in keeping with the educational and moral values of the PRIA

- g) To Transfer of appropriate information, science and information technology as well as improvement of village arts and crafts.
- h) To organize, promote, encourage Self-help groups, Mahilamandals and inculcate thrift habit among women
- i) To work purely as a non-profit and non-commercial Society.
- j) To provide residential accommodation and to educate, train and assist financially or otherwise in the education and training of social workers, staff, students, orphans and child labour.
- k) To channelize the financial performance of the Khadi and Village industry and other public institutions of the development of poorer sections of the Society.
- I) To promote welfare and support to Handicapped persons.
- m) To promote environmental awareness programmes.
- n) To promote creche units (F.C.C) Core course Family awareness center.
- o) To cater to the education of children with special needs.
