No amendment or alterations shall be made in the purpose of the association unless it is voted To 2/3 of its members present at a special meeting convened for the purpose and confirmed To 2/3 of the members present at a second special meeting.

Clause No.10 – Winding up:
In case the society has to be wound up the property and funds of the society that remain of the discharging the liabilities if any shall be transferred or paid to some other institution with similar aims & objects.

Amendments

Clause No.8 – Funds:
The Funds shall be spent only for the attainment of the objects of the society and no portion thereof shall be paid or transferred directly or indirectly to any of the members through any means. The funds will be invested in the manner prescribed and deposited in the institutions mentioned in the provisions of section 11 (5) of the Income Tax Act, 1961.

Clause No.9 – Amendments:
No amendment or alterations shall be made in the purpose of the association unless it is voted To 2/3 of its members present at a special meeting convened for the purpose and confirmed To 2/3 of the members present at a second special meeting. And no additions, amendment in the objects shall be made without the prior approval of the Director or Income Tax (Exemptions), Hyderabad

Clause No.10 – Winding up:
In case the society has to be wound up the property and funds of the society that remain after discharging the liabilities if any shall be transferred or paid to some other society with similar aims & objects and registered U/s 12A of the Income Tax Act, 1961.

Clause No.11 – Audit and Maintenance of Accounts.

The accounts of the Society shall be maintained for the financial year ending with 31st March of every year and got it audited To the Chartered Accountant and audit report thereon will be submitted to the Income Tax Department every year.

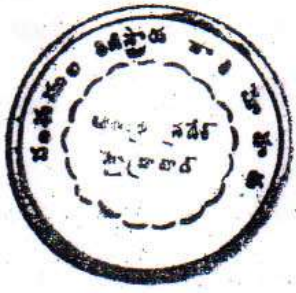

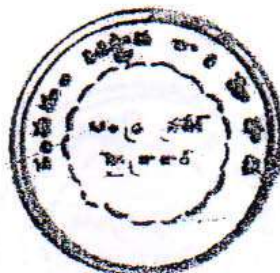

SOCIAL ACTION FOR INTEGRATED DEVELOPMENT
(S A I D)
RULES & REGULATIONS OF THE SOCIETY

1. The name of the Society: The name shall be SOCIAL ACTION FOR INTEGRATED DEVELOPMENT, referred to as the society in these Rules and Regulations.
2. Office: Its Head quarters shall be at H.No.8-2-293/82-B/18-1/A, Jawahar Nagar Colony, Jubilee Hills, Hyderabad-500 033.
3. Jurisdiction: Tts jurisdiction shall extend to the whole of Andhra Pradesh Rural areas.
4. Membership: The society shall admit two kinds of members: Ordinary members and Institutional members. The period of membership shall be the Financial Years.
 - b. Ordinary membership shall be open to those who pay Rs. 10/- as annual subscription with the approval of the Executive committee.
 - c. Institutional membership shall be open to organisations and associations, who voluntarily join the society and who enrol themselves at a subscription fee of Rs. 100/- per annum.
 - d. Annual dues of members shall be for the calendar year, which shall also be the financial year and shall be payable by January 10th of each year.
 - e. The Executive Committee shall have the right to remove any member for activities prejudicial to the objectives of the society after giving such a member as opportunity to show cause for such removal.

ANNUAL GENERAL BODY MEETING:

1. There shall be an annual meeting of the society convened after 15 clear days notice. The notice shall contain the time and place of the annual meeting and also the purpose for which the meeting is proposed to be convened.
2. The annual meeting shall be held preferably on the 10th of the each year in the month of March. In that meeting the annual report of the Governing body together with a statement of accounts duly certified by an Auditor, shall be presented and passed.
3. The Governing body, inclusive of the office bearers, shall be elected by the general body, for a give years term and no member of the Governing body shall held office for more than two successive terms. These selected shall enter on their duties hence forth and shall continue in office until their successors, are elected.
4. The General body shall appoint the Auditor of the society for the coming year.

VI. FUNCTIONING: 1. The Executive body : The exact number of executive body including office bearers are Seven (7).

A. PRESIDENT:

1. He shall preside at all meetings of the governing body and General body, any rulling given by him at such meetings shall be final.
2. He shall be the authority to issue any statement in the name of the society.
3. He shall have the powers to appoint staff and other workers and has also general powers to retrench.
4. He has power to take disciplinary action against the staff or workers as to keep up the discipline and order of the Society.
5. The President shall have the right to receive any gifts whether money or in any kind for the fulfilment of the objects of the society.

B. VICE PRESIDENT:

1. He shall act as President during the absence of the President and shall exercise during such period all the powers of the President.
2. He shall also exercise power of the President delegated to him.

C. SECRETARY:

1. The Secretary shall convene, Co-ordinate and conduct all meetings of the society in consultation with the President.
2. The Secretary has power to correspond, negotiate or enter into contract with Government Departments, Private persons in our country or foreign countries in the interests of the society.
3. The Secretary shall maintain a joint account with the consultation of the President in any bank approved by the Executive committee.
4. The Secretary shall be the co-signes for all banking transactions.
5. The Secretary shall be the Chief Executive of the Society.

D. TREASURER:

1. He will have the General supervision of the assets of the society. He will arrange for the annual audit and Present the annual statement of accounts and other financial statements to the general body meeting in consultation with the secretary.
2. He shall maintain all accounts, receipts, vouchers as required for accounting cash receipts and payments.

E. MEMBERS:

The two members nominated by the President, shall be used for any type of executive work as directed by the President.

F. QUORUM:

The quorum of the General body and exeutive committee meeting shall be two thirds of the members. The resolutions of general body/executive committee shall stand or inpassed if it is voted by a simple majority.

VII. SUITS AND LEGAL PROCEEDINGS:

All suits and legal proceedings, initiated by the society shall be constituted and prosecuted in the name of the society by the Secretary.

VIII. FUNDS:

1. The President shall have powers to raise funds by way of donations, subscriptions or benefit shows and such others.
2. All the funds of the society shall be deposited in State Bank of Hyderabad or any other Bank (approved) on joint account.
3. The funds of the society shall be utilised for the benefit and improvement of the society and shall not be otherwise utilised.
4. The funds or portions of its shall not be paid or transferred directly or indirectly to by any of its members by any means.

IX. AMENDMENTS:

This constitution may be altered or amended by a vote of not less than two thirds of the members present at any meeting of the society provided previous intia mation of such alterations or amendments have been given to the members by the notice convening the meeting. the purpose and confirmed by 2/3rd of the members present at a second special meeting.

X. WINDING-UP:

In case the society has to be wound up, the property and funds of the society that will remain after full satisfaction of all the liabilities of the society will be transferred to some others institution with similar aims and objects.
