SAMPADA UDUPI is the social development wing of the Diocese of Udupi which is committed to influence positive change and work towards development in the lives of the needy and deserving people of the Udupi District. It has been positively and tangibly responding to the needs of the poor and marginalized brothers and sisters in the District of Udupi, irrespective of creed, gender and family background through developmental activities in various villages. Primarily Sampada means prosperity or abundance. In the words of Jesus 'I came that they may have life, and have it abundantly'. People who come in relationship with SAMPADA should have 'life in abundance'. 'Sampada' as a noun, in Sanskrit, means 'standing with the feet together or even' or 'empowerment'. Keeping both the meanings in mind SAMPADA UDUPI works to achieve 'the empowered people having life of abundance'. Like any other organization, the SAMPADA UDUPI also has its Vision Statement, Mission Statement, Goals and Objectives. Even though it started to work from 2013 June, finally on Saturday, 7 June 2014, 'SAMPADA UDUPI' was registered as a Trust at the S.R.O. (Sub Register Office) Udupi. With women empowerment; taking care of the environment; being compassionate towards people who are suffering; and by helping the marginalized farmers and vulnerable people in the society, taking care of the ecology of the place, it has wiped the tears of suffering, helped the needy and empowered the marginalized and vulnerable people in the past 9 years.

- **Laudato si' Save the Mother Earth:** By 2025, 2,000 are convinced and actively involved in 'saving the Mother Earth' through various activities.
- **Sparsha' Cancer and Health related programme:** By 2025, 15,000 people are aware of cancer and life style diseases, and adopt a healthy lifestyle.
- **Education and Holistic Child Development:** By 2025, 660 children are helped to pursue their education and guided to live a value-based life.
- **Care for the needy:** By 2025, 500 families live a happy lifeby fulfilled basic needs.

·Women Empowerment programme

This programme focuses on marginalized women in the Udupi District, empowering personally, economically, socially and politically through the Self-Help Groups. 6000 middle class and poor women have been targeted as part of this programme. The long term strategic expected outcome would be that the women, after forming Taluka Federations and the District Federation, will have their own Cooperative Society which is actualized in this year. Training, inclusion and empowerment activities have been the part of the programme. We have been already seeing positive changes in the life of women in all the spheres of their life.





·Development of Small and Marginalized farmers

This programme focuses on the all-round development of small and medium scale economically backward farmers. Together with the organic farming to provide healthy food to the public, we concentrate on the steady increase in the agricultural income of farmers. Organizing the farmers in small groups, registering them, training on organic practices and guiding them for marketing their products through the FPOs have been the main activities of the programme.

·Laudato Si' Save the Mother Earth.

This programme focuses on saving the ecology of the Udupi District for a healthy living of the present and the future generations of the district. 'Laudato Si', Save the Mother Earth – is the main activity, which was a competition, that concluded in this year. Rainwater harvesting, saving water, less use of plastic and making use of natural energy, protecting animals, terrace gardening have been the highlight of the programme. Encouraging an eco-friendly lifestyle through reducing, reusing, recycling and renewing has been the main thrust. Training, awareness and implementation through a strong base of more than 50 volunteers have been the activities of the programme.



·SPARSHA - Concern and care about cancer and lifestyle diseases.



This programme focuses on the life style diseases rapidly spreading in our district, mainly cancer, diabetics, blood-pressure and other diseases. We have been giving awareness to people regarding cancer and other lifestyle diseases and the need to adopt a healthy lifestyle. We have check-up camps conducted in the villages. It is our focus that people grow their own vegetables, fruits and herbal plants which prevent them from life style diseases.

·Integrated Child Development Programme

This programme focuses on support for economically poor children's education which would gradually prevent child labour. The beneficiaries have been the children who are in the age group of 6-14

years. 500 children from the Udupi District have been targeted to benefit in this programme. Our mission has been to help children reach their goal in life for which we provide support till they complete their education and stand on their own feet. Physically and mentally challenged children too are our beneficiaries.

PROGRAMME HIGHLIGHTS

2022-23

1. Empowerment of Women in the District of Udupi

"As women achieve power, the barriers will fall. As society sees what women can do, as women see what women can do, there will be more women out there doing things, and we'll all be better off for it." – Sandra Day O'Connor

As per our strategic plan, our objective for **Women Empowerment Programme is: By 2025, '8,500 empowered women will be financially stable, politically active and organizationally united'.**

This year we concentrated mainly on the financial problems faced by women after COVID pandemic. We empowered women to take up income generation activities of small-scale. Through Samrudhi organization of Bangalore and through Charity Trust of the Diocese of Udupi, financial help was arranged. As per our record this year, nearly 299 women started their own income generation activities to make easy to carry the



financial burden of their families. To help women in the future **Sugamya Mahila Sauhardha Sahakari Sangha Niyamitha**, **Udupi**, a cooperative bank has been started by the members of SHG women, through the leadership of their district body **Sugamya Jilla Mahila Vokkuta**, **Udupi District**.



This year on the topics of Stress management, Documentation, Information regarding Government schemes; Strengthening various structures, Self-employment; Gender equality, Christian value based leadership; Social Analysis of SHGs, Information about Sauhardha Sahakari and Women empowerment we have conducted 633 training sessions benefitted by 9,071 women.

142 women have started various income generating activities like piggery, poultry, goat rearing, dairy farming, tailoring, beauty parlour, petty shop, fish trading, etc, through a loan of \gtrless 31,43,076 from various sources excluding loan availed from SHGs but including various government schemes. 157 women availed \gtrless 50,24,000 loan from SHG's to start or to develop various income generating activities.

Through SHGs this year, women have saved ₹ 1,28,93,625 and availed ₹ 6,71,27,200 loan for various purposes.

209 women availed ₹ 11,86,748 from various government schemes, that is, from Ganga Kalyana Yojana; MNRGA programme; roof top harvesting, Vermi compost pit, etc.

2. Raita Bazar - Development of Small and Marginalized Farmers

Raita Bazar' - agriculture and Organic Farming Programme was initiated with an objective that **"By 2025, 1200 small and medium farmers, through organic farming and by cooperative activities increase their family income by 25%**". This year instead of organization working as a unit, we availed the help of the three local Farmer Producer Organization, that



are of Kapu, Nitte (Karkala) and Hiriyadka (Udupi). But individually we had training for small groups of farmers, who are interested on organic farming.




02 training sessions were conducted on the topic 'Training on Family livelihood enhancement' in which 84 farmers benefitted. As a result of last year's and this year's training, 846 new members joined these FPOs.

Till 31st March 2023, a total of 1,772 farmers have enrolled to 3 FPOs namely Kapu FPO, Nitte FPO and Kural FPO (Hiriyadka, Udupi). 16 of our members whom we promoted became directors in these FPOs.

3. Laudato Si: Save the Mother Earth

"Plans to protect air and water, wilderness, and wildlife are in fact plans to protect man." – Steward Udall

'Laudato Si – Save the Mother Earth' programme was our third important programme with its objective, 'By 2025, 2000 families will be convinced and actively involved in 'Saving the Mother Earth' through various activities. SAMPADA conducted various training sessions to provide awareness to the people of the district regarding protection of the Mother Earth.



106 training sessions regarding ecology were conducted on topics covering rainwater harvesting, organic farming, Save Mother Earth; medicinal plants and their uses; 'Laudato Si' implementation; 'Swatch Bharath Abhiyaan' and waste management. 1,278 people attended these training sessions.

As a result of the training, 1,024 saplings were planted, 250 rain water harvesting pits were dug, 13 bore wells and 48 open wells were refilled with rain water and 01 small bund was built on rivulet. 148 people participated in Swatch Bharath Abhiyaan.

3.1 'Laudato Si: Save the Mother Earth' Competition.

The prize distribution function was held on 28 May 2023 at Udupi. The winners were: 1st Prize Jyothi Self Help Group, Karkala Town; 2nd Prize to Chaitanya Federation, Miyar, Karkala Taluka. 3rd Prize was given to 4 participants: St Cecily's Convent Udupi; Mrs Jacintha D'Souza, Belman; Mr. Nagesk Kamath, Katapady and Mrs Pricilla DMello, Shankarpura. During the programme the book titled **'Amcho Gavn Bhumi Voynkut Koryam'** (Make Our Land a Paradise) written by Rev. Fr. Reginald Pinto was released.





Laudato Si Family

Mr Arun D'Silva and his family from Sanoor Village of the Karkala Taluka of Udupi District were recognized as '**District level eco-friendly family**' for their enormous contribution for saving the Mother Earth and the environment. They were honoured on 28 May 2022h during the prize distribution programme of 'Laudato Si: Save the Mother Earth' Competition.

4. SPARSHA - Concern and care about cancer and lifestyle diseases.

Donation drive for 'Sparsha - instilling hope', cancer programme and various training programmes were conducted.



04 cancer detection camps in collaboration with KMC Hospital Manipal and Cancer Society of India were conducted in which 258 patients participated. As a part of the programme, 17 training sessions on cancer and health awareness were conducted by which 372 people benefitted.

As a result of the training, nearly 129 families have started either vegetable garden, fruit garden or medicinal plant garden, this year. The total number of families with these gardens was 3,912.

We organized **hair donation drives** through which 121 people donated their hair for the cause of cancer. Through individual donors and through box collection we collected an amount of ₹1,81,591. This year we have financially helped 10 cancer patients with an amount of ₹ 2,00,000.

5. Educational and Holistic Child Development Programme

"Education is the passport to the future, for tomorrow belongs to those who prepare for it today." – Malcolm X, Civil Rights activist.

To assist a child, we must provide him with an environment which will enable him to develop freely. Keeping this in mind, we helped children and youth to pursue their education and they have been guided to live a value-based life. These youth are either from economically poor or marginalized and vulnerable families. Various organizations like KCWA, Kuwait,



CODPs EDUCARE programme and our Education Fund have been the main sources. Due to new FCRA policy we have not been able to get funds from Goretti Stichting, Caritas Prague and Caritas Slovakia.



This year we have helped 84 youth to avail an amount of ₹53,68,000 from CODP EDUCARE fund. This amount is interest free loan which the students will have to pay back after their education. SAMPADA UDUPI is a bridge between the student and EDUCARE.

SAMPADA UDUPI has helped 12 students with an amount of ₹66,600.

Meanwhile, 352 children have been enrolled under Integrated Child Development Programme (ICDP).

Through the **SAMPADA-KCWA Education Fund**, we have helped 15 students with an amount of ₹ 5,97,215.

6. Samanwaya: Udupi District Federation of Men's Self-Help Groups Inaugurated

Most Rev. Dr. Gerald Isaac Lobo inaugurated the first ever Udupi District Federation of Men's Self-Help Groups on Sunday, 16 October 2022 in the Mother of Sorrows Church Hall, Udupi by unveiling the Logo of the federation and lighting the lamp formally inaugurating the Federation. The establishment of the **Samanvaya Udupi District Federation of Men's Self Help Groups** is the first of its kind in India. Our purpose is that the men of different parishes, who have come together to form the District Federation, would foster a sense of belonging and support to each other in the future days.

9. Care of the needy:

Our objective was - 'By 2025, 500 families live a happy life by fulfilled basic needs'.

The basic needs of humans have been divided into three parts – Housing, health and other necessities. Under housing we help the needy families to repair old houses; help them during the construction of new houses and help them to construct toilets and bathrooms. Under health, we help the needy for their medical treatment. Under other necessities, we help them in emergencies like flood or other natural calamities, any sudden tragedy occurring in the families, etc.





7.1. Housing:

This year 13 families who were constructing new houses and 08 families who wanted to repair their houses were given an amount of ₹9,30,000

7.2 Health

This year an amount of ₹ 29,47,420/- has collected from the public to strengthen Medical Fund. Under medical help we have helped 31 patients with an amount of ₹ 4,75,000/=.

7.3 Charity "It's not how much we give but how much love we put into giving." — Mother Theresa

Under Charity scheme we have helped 05 families with an amount of ₹58,900/=



8. Men's Self-Help Groups.

"The real man smile in trouble, gathers strength from distress, and grows brave by reflection." – Thomas Paine

Observing the success of women Self Help Groups (SHGs), men too requested us to start their SHGs. Women SHGs were mainly for women empowerment, but men SHGs were formed to unite, develop and have fraternal relationship with each other. Even though the rules were same, the objectives and goals were different. We have get together of Taluka Level men SHGs.



23 training sessions were conducted to start new SHGs in which 275 men attended. 22 new SHGs have been started with a membership of 286 men, this year. This year men SHG members have saved ₹ 21,03,150 and availed ₹ 54,01,000 loan for their activities.

1. Sugamya Mahila Sauhardha Sahakari Sangha (Ltd) Udupi: First Self Help Groups, then village level federations, then Taluka Federations culminating in Sugamya District level Women Federation, Udupi District. The offshoot of it is Sugamya Mahila Sauhardha Sahakari Sangha (Ltd) Udupi, to cater financial needs of our women. It was inaugurated on 02nd February 2023 at Udupi. 2. Independence Day Celebration: 2022 year's Independence Day is special because India is celebrating 'Azadi Ka Amrit Mahotsav' a Government of India initiative to honour and celebrate 75 years of India's independence and the magnificent history of its culture, people and accomplishments. Independence Day was celebrated at self Help Group level in the villages.





3. Our Board member is awarded at national Level.

Mrs Jenet Barboza our Board member was awarded as '**Best Achiever Women**' in the National Level Women Conference at Lucknow in the month of October 2022 by Women Commission, Conference of Catholic Bishops of India.

4. Deepavali Celebration.

Deepavali the festival of light was celebrated by the Self Help Groups in their vicinity, inviting and involving the neighbours and with their family members.





5. Inter religious get-together: Our Federation members had interreligious dialogue with women of different faith. Understanding each others faith bring harmony in the community.

6. Kapu FPO Company:

The Kaup Farmers' Produce Company (Ltd.) started by SAMPADA UDUPI in collaboration with Atal Incubation Centre, Nitte and managed entirely by women creating history in the 'Women Empowerment' movement was inaugurated in a well-attended function in the Saud Sabha Bhavan, Shirva-Manchakal on Monday, 26 September 2022.
