





VIII. BOARD OF TRUSTEES

- 1. The Founders of the trust shall be Trustees for life.
- 2. The founder trustees of the trust shall form the Board of Trustees, hereafter called as "BOARD".
- 3. The Board has the power of take further trustees for a maximum period of 5 years.




